\_\_\_\_\_ New Service, \_\_\_\_\_ amps (\$50.81 per 100 amps of service or fraction thereof.) Example, Up to and including 100 amp = \$50.81. 125,150 or 200 amp = \$101.62. 225 thru 300 amp = \$152.43 etc.

**NOTE:** Connection Fee for new residential construction is paid with the issuance of the building permit.

**Increase or Replacement of Existing Service Equipment (except damage caused by storm event (with or without meter base replacement, 100 amp min.)**

\_\_\_\_\_ Increase from \_\_\_\_\_ amps to \_\_\_\_\_ amps: \$32.24 plus \$0.187 per amp of increase. For example: Increase from 100 to 125 amp = \$32.24 plus \$4.68 = \$36.92 Increase from 100 to 200 amp = \$32.24 plus \$18.70 = \$50.94.

\_\_\_\_\_ Conversion from OH to UG Service for One and Two-Family Residential Service Laterals: \$334.00

**(NOTE: If conversion includes an upgrade, only the upgrade fee applies.)**

\_\_\_\_\_ Replacement of existing service without change to amps: \$32.24 (*Exempt if storm damage*)

**Remodel / Addition or Alteration Charges**

\_\_\_\_\_ Branch circuit wiring with no change in service equipment = \$33.48

\_\_\_\_\_ Re-inspection Fee=\$47.73 second re-inspection or \$95.44 Subsequent re-inspection for same violation

\_\_\_\_\_ Construction started without appropriate permit(s) = 3x cost of permit(s)
